

Event release waiver:

Please carefully read the following terms and conditions related to your participation in Linda Deir ("Deir") together with Ray Holley ("Holley") event and or workshop, and or webinar (the "Event") which is conducted by Linda Deir Author ("LDA") and the Channeled Readings, LLC ("CR"). By registering for the Event and signing below, you (the undersigned "Participant") signify your acceptance of these terms and conditions (the "Agreement").

L. Participant warrants and represents that Participant: (a) is over the age of eighteen (18); (b) shall be respectful and professional to LDA, CR, its affiliates, and other participants for the entirety of the Event and that if LDA determines, in LDA's sole discretion, that Participant is being offensive or disruptive at the Event, LDA may remove Participant from the Event and Participant will not receive a refund; (c) will not film or record the Event, and that if Participant does film or record the Event, will be removed from the Event, will be required to immediately delete all recordings of the Event, and will not receive a refund; (d) understands that all information ("Confidential Information") presented at the Event are copyrighted, proprietary, confidential, and/or otherwise owned or controlled by LDA and or CR, that Participant will not seek to use or replicate any Confidential Information in any manner, including, without limitation, reporting on any Confidential Information or posting a summary or review of the Event on any website of social media page, and will hold all Confidential Information strictly confidential in perpetuity, until such time LDA and or CR directs otherwise in writing or makes such Confidential Information public; (e) understands that all information disseminated at a Event, including, without limitation Confidential Information, cannot replace or substitute for the services of trained professionals in any field, including, without limitation, the mental, financial, medical, psychological, or legal fields, and that LDA, CR and LDA's and CR's affiliates, including Deir and or Holley, is not offering any professional, personal, medical, financial, or legal advice as part of an Event and no information contained in the Event should be construed as such advice; (f) understands that adult content may, and is likely, to be discussed at the Event regarding an individual's personal and/or professional growth, and if Participant is uncomfortable with such adult topics, Participant should not attend the Event and will not be extended a refund if Participant attends anyways; and (g) understands that a breach of this Agreement by Participant may cause irreparable injury to LDA, CR or its affiliates, and that in the event of an actual or threatened breach, LDA and or CR shall, in addition to all other available legal and equitable remedies, be entitled to injunctive relief restraining any conduct prohibited herein.

2. LDA and or CR reserves the right to cancel or reschedule any Event at any time for any reason. In the unlikely event that LDA and or CR does so, Participant will receive a full refund or the opportunity to transfer their registration to a different Event on another date. LDA, CR, LDA's, CR's affiliates, including Deir and or Holley, are not responsible for any consequential loss or expenses, including, without limitation, travel and accommodation expenses, incurred by Participant as a result of cancellation.

3. Participant understands that an Event is recorded, however we frame the camera tightly on Deir and or Holley and only intend to capture her and or him on camera - not the Event Participants. Any Participant that interacts will, from their webinar options, will do so from, typing into the Q&A chat, or the audio, or the video during the webinar. Participant: (i) agrees that LDA, CR and its affiliates may record, or otherwise use Participant's image and participation at an Event (the "Footage"); and (ii) irrevocably grants and assigns to LDA and CR and its affiliates the exclusive and perpetual right, throughout the universe, to display, and/or create derivative works of the Footage and (iii) understands

that Participant's contributions to the Footage will be wholly original and will not infringe or defame on the rights of any third party. All right, title, and interest in and to the Footage is a work made for hire made for the benefit of LDA, and or CR shall be deemed assigned by Participant to LDA and or CR, throughout the universe in perpetuity. Participant waives any moral rights Participant has in the Footage.

4. Participant irrevocably and forever releases, discharges, indemnifies, and holds LDA's, and CR's affiliates harmless from any damage, loss, liability, or claim, whether such liability is by way of direct, indirect, consequential, special, exemplary or other damage, which arises in connection with an Event or the breach of this Agreement including, without limitation, by way of the alteration or publication of the Footage, from any claim of defamation, invasion of privacy, or from any personal injury incurred in connection with a Event. Participant is alone responsible and accountable for Participant's decisions, actions, and results in life, and by the participation in the Event, Participant does not hold LDA, CR and or their affiliates, including Deir and or Holley, liable for any decision, action, or result that Participant makes due to Participant's participation in an Event.

5. This Agreement represents the entire understanding between the parties and supersedes any prior agreement with respect to the subject matter. LDA and or CR may assign this agreement to any third party. The laws of Arizona shall govern this Agreement and any dispute related hereto shall be resolved in the courts located in Arizona Maricopa County. Participant acknowledges and agrees that Participant shall have no right to and hereby waives any right to obtain equitable or injunctive relief in regard to the Footage and or attending the Event. Participant understands that Participant will not be covered by any LDA and or CR insurance policy. All notices to LDA and or CR hereunder shall be sent to linda@lindadeir.com.
